- 4.10 Chairman of *Discussion Group 85*. The group was founded in 1985 by senior professors at the University of Stellenbosch and played an active role in the period 1987 to 1994 in agitating for an acceleration of the reform process. The group held in-depth discussions with political leaders (including the State President and several ministers) over the entire spectrum of key reform issues.
- 4.11 A Trustee of the Board of *Arts and Culture South Africa* (ACSA) founded by the ANC Cultural Conference in 1993. ACSA was dissolved in 1995.
