- 1. To mobilise, develop and employ scarce resources as FULLY as possible and (where human beings are concerned) as HUMANELY as possible i.e. without causing an "exploitation" of neither nature nor human beings.
- To allocate scarce resources as EFFICIENTLY as possible to reach a high level of STATIC EFFICIENCY (i.e. to reduce waste to a minimum) and to stimulate technological and organisational progress to reach a high level of DYNAMIC EFFICIENCY.
- To attain the highest degree of PRODUCTION EFFICIENCY in the production process (in the narrow sense) and to produce those consumer goods that will satisfy needs more or less in the order of their intensity.
- 4. To distribute income, property and opportunities between the different groups and individuals in society in an EQUITABLE and a fair manner.
